THE MASTER'S MESSAGE

This will be the last Newsletter issued in my year in Office so I could use it an occasion to look back over that year but I seek to look forward instead.

Elsewhere you will read about the first post-Charter Election of Officers and I am highly confident that I am passing on the baton to a team of the highest quality; I say "team" because (in contrast to some other Livery Companies) the Master, Wardens and Clerk work as a team to deliver the best possible performance, assisted by our excellent Beadle and Assistant to the Clerk. I have been fortunate in having arguably the best team in the Livery and I thank them all for that. I also wish to thank the Past Masters, particularly Chris Dancaster and John Rushton, for valuable support.

In assuming office in October 2011, I set myself some tough targets, all of which (I thought) should have been achievable but, if I was being honest with myself, I did not achieve everything I sought to do. I am greatly reassured that my successor has built into his programme those aspirations where I fell short of target. One such is featured on the next page, i.e. the Company's involvement in various schools-related projects where I hope to see real expansion in the Company's activities. You yourself can participate, sometimes for as little as 1-2 hours, and make a genuine contribution to changing the lives of underprivileged children.

A great regret of my year in office has been the poor support given by Members to Company functions: while 45 members (19%) attended my Installation (which was better than in recent years), only 29 members (12%) attended the Annual Banquet and 38 members (16%) the Charter Banquet (all the figures exclude the Court). The Annual Recital has already been postponed once because of the poor subscription by members and the rescheduled Recital has (at present) only three (3) non-Court subscribers, and one donor in lieu, from >250 members i.e. less than 2% in support. I appreciate that not every member might find the content of the Recital appealing but this is the only major fundraising event of the year for the Company's Charity (which all members have undertaken to support) and only ONE member has made a donation in lieu of attendance.. What makes the membership's lack of support so striking is that thirty-seven (37) Livery Companies have accepted to attend and I will be acutely embarrassed if the Livery attendance dwarfs (as it presently does) our own members' attendance. May I most earnestly implore you to do whatever you can to rectify this profoundly disappointing situation.

Let me close on a positive note (first) by thanking, most warmly, all those members who have supported the Company in the past year - I wish you every good fortune in the years to come and (second) by thanking the Wardens, Past Masters, Court, Clerk, Assistant to the Clerk, Beadle, Toastmaster and the Rev. George Bush for truly wonderful support, memories of which I shall treasure for at least the next 41 years.
