THE MASTER'S LECTURE

I am very pleased to report the success this year of the Master's Lecture for Students which was given at my invitation by our Liveryman Kay Linnell, a Chartered Accountant MBA and FCIArb. She is currently based in the London office of Morley Scott, Chartered Accountants, and responsible for developing dispute resolution, investigation, arbitration and conciliation as part of the forensic, expert and due diligence services offered by the practice. Her experience covers arbitration, business management, consulting, tax in depth enquiries, tribunal representation and litigation.

Kay's title for the lecture was "Arbitration and Fraud" which addressed the issues concerning the impact of dishonest conduct in arbitration and covered the implications, in terms of the legislation, of money laundering, the proceeds of crime, data protection and human rights.
